- ✗ In cases **that can be solved** by either the Network Commission, Audit Commission, Juridical Commission or Comité Directeur separately
- ✗ When there aren't two of the above mentioned organs coming forward with an **official request**
- ✗ When the case would be about **individuals** and not about ordinary members (AEGEE locals and AEGEE Working Groups)

- ↪ The discussion departed from a request for advice related to financial management in AEGEE.
- ↪ It also touched issues like the professionalism of AEGEE members, the extent of the jurisdiction of the Members Commission and the efficiency of the current disciplinary system in the European level of AEGEE.
- ↪ Follow-up: We will communicate these thoughts to the AEGEE bodies, which may be interested or concerned.
- ↪ Follow-up: We will make sure that the outcome of the discussion on the issue will be transferred to the next Members Commission and we will encourage the CD to do the same.
